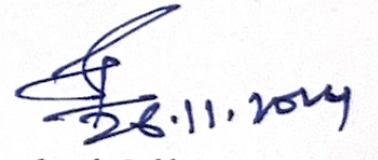

(The departmental Senior Scientific Officers (HRD/Quality Control) with 05 years regular service in the pay scale of Rs-8000-13500/- shall also be under consideration along with

	outsiders and in case he is selected for appointment to the post, the same shall deemed to have been filled by promotion. (Period of deputation (ISTC) including period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing date of receipt of applications).
