Invitation of quotation for the Rate Contract for refilling of Various Gases in Forensic Science Laboratory, Rohini, Delhi-85. The last date of receipt of quotation is on or before 07th October 2024. The terms & conditions are as under:

Terms & conditions for the Annual Rate Contract of refilling of various gases in Forensic Science Laboratory.

1. The Gases refilled by the vendor should be of pure and standard quality.
2. The rates should be inclusive of delivery charges.
3. Any item which is found to be defective, or not of the desired quality etc. shall not be accepted by this office.
4. The payment to the contractor will be made against the bill of the supplied/refilled gases. The contractor is required to submit the satisfactory report from the concerned divisions/officials and the same shall be enclosed along with the bills.
5. The supply of gases should be made within working hours 09:30 AM to 6:00 PM and obtain the satisfactory report on completion of the work by concerned officer/official.
6. The requirement may vary from time to time. This shall be kept in view by the prospective bidders while submitting their bids.
7. The Director, FSL reserves the right to award the contract to more than one contractor on common lowest rates or split the same. The contract shall normally be awarded to the bidder who emerges L1. in majority of the items on common minimum rates i.e., the L1 bidder has to match the L1 rates of the other bidders for the items for which his rates are higher.

8. No labour charges whatsoever will be given to contractor in any case as the price bid contains the comprehensive amount.

9. Before quoting the rates, contractor may visit the site to ascertain the existing conditions in FSL. The cost to visit the site will be borne by the contractor. The Director FSL, will not be responsible for any injury or losses sustained by agency's personnel during the performance of their duties and also for any damages. With all the liabilities arising out of any provisions of the labour laws / Acts / enactments / instructions in-force or enacted from time to time.

10. The Director FSL, has the rights to terminate this Annual Rate Contract at any time during the contract by giving one month's notice without assigning any reason whatsoever, if the services are found to be unsatisfactory. In case, if it is found at any stage during the tenure of the contract that sub-standard /inferior quality items supplied, necessary action will be taken against such tenderer which may include termination of contract.

11. The duration of the Annual Rate Contract shall be one year from the date of awarding the contract, which may be extended for another period of one year subject to satisfactory performance report & approval of competent authority.

12. The tendered should also submit the Annexure-I (format attached herewith) along with quotation and signed & stamped copy of the terms and conditions.
