Promotion: Senior Scientific Assistant (PHOTO) in pay level-6 (Rs.35400-112400) with 05 years regular service in the level.

Deputation (including short-term contract):

Officers under the Central/State Govts./UTs/Recognized Institutions/Public Research Sector Undertakings/Semi-Govt./Autonomous Organizations:-

(a) (i) Holding analogous posts on regular basis in the parent cadre/department;

OR

- (ii) With 05 years service rendered after appointment to the post on a regular basis in the level 6 (35400-112400) in the parent cadre/department; and
- (b) Possessing the educational and other qualifications prescribed for direct recruits under column No. 7.

Note: Period of deputation (ISTC) including period of deputation (ISTC) in another ex-cadre immediately preceding held other appointment in the same or some Organization/Department of the Central Government shall ordinarily not exceed three years. The maximum age-limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing date of the receipt of applications.
