Note: The departmental Junior Scientific Officer (HRD/QC) in the pay scale of level-7 (Rs. 44900 -142400) with 05 years regular service in the grade or the existing Senior Scientific Assistant (HRD/QC) on the date of notification of these rules in the pay scale of Level-6 (Rs.35400- 112400) with 08 years regular service in the grade shall also be considered along with outsiders and in case the department candidate is selected for appointment to the post, the same shall deemed to have been filled by promotion.

(The period of deputation/ including period of deputation/contract in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not to exceed 03 years. The maximum age limit for appointment by deputation including short- term contract shall be not exceeding 56 years as on the closing date of receipt of applications).
